Bowls England Regulations 9, 9A and 9B prohibit players who have been expelled and in certain circumstances those that have been suspended from an Affiliated Club, from entering your tournament.

Expulsion: No member who has been expelled by his/her Club, a County Association, Bowls England or as a result of an appeal to a County Association or Bowls England shall be admitted to membership of any Affiliated Club or be permitted to play or practice bowls on the green of any Affiliated Club except with the consent of the Board of Directors of Bowls England. "Affiliated Club means a Club which is affiliated to Bowls England".

Suspension: No member, who has been suspended by his/her Club, a County Association, Bowls England or as a result of an appeal to a County Association or Bowls England shall be permitted to play in any form of competition in his/her own Club.
